Because the right to live, the right to upbringing, the right to education are all our human rights. If grandmother did not receive this money, how would she feed herself and her husband? If we look carefully, we will see many such examples around when media has played an effective role.

# **NEGATIVE ROLE OF MEDIA:**

Media is not only a boon but also a curse, there are some negative aspects about media. Today, the media is forgetting its responsibility due to marketism and selfishness. In the newspapers, in the name of human rights abuses, most of the news of police detention and jail activities and deaths are published. But incidents of human rights abuses do not find the place that should be found. "The electronic media, rather than the newspapers, is more and more authoritative about the incidents related to human rights abuses. Media today needs to pay more attention to the issues of protecting the rights of the deprived." (Mellalli, 2013) In many cases, it is seen that the media ignores its role and only takes up their ratings, which is unfair. There should be freedom of media or press, which is also being found, but many times media persons do their own free will in the name of freedom. To increase the live coverage and TRPs cross all the limits. Jae is unfair, to spread sensation, he does not miss putting the security of the country on the claim. The 26/11 terror attack in Mumbai was broadcast live by the media. Due to which the terrorists were getting full details of the action being taken against them by the security forces and it was their help. The lives of hostages, hotel workers, and security personnel trapped in the Taj Taj hotel were threatened. In this sequence, the media also published many misinformation.

The media is interested in covering people belonging to such a class, to which he himself feels connected. "Since a large share of the media belongs to the large and upper class people, the coverage of events that took place in the life of the same class is given more attention."<sup>1</sup> The police has also started recognizing this attitude of the media. This is the reason why criminal cases on the lower class are not easily registered even in police stations. Even if recorded, a major incident is transformed into a shadow. For example, rape is converted into a minor molestation case. At the same time, the matter is shown to be resolved in a hurry. The judicial process is also often influenced by media reports.

"Today's media is controlled by business houses unlike the era of independence. Especially for television channels, big capital is needed."<sup>2</sup> Media funded by large capital and advertising revenue will not ignore the interests of its owners and corporate advertisers. So if it wants the news of the right to employment and the right to information and to the people fighting for the rights of the people, Aruna Rai or the fight against the rights of tribal displaced people Medha Patekar or suppression of paramilitary forces in North East Shilpa Shetty and Mallika Sherawat are shown walking up the ramp to the models, and their concerns are revealed automatically, not showing the performing erasharmila. "It is a reflection of this trend that under the pressure of business and capital, the media is increasingly eating its society and human rights oriented advocates."<sup>3</sup> His social sensation is getting blunt.

# ELECTIONS BEFORE THE MEDIA:

Media is very important to protect human rights. "The media is expected to boldly and faithfully but the media has to face a number of elections to play its important role

in the protection of human rights."<sup>4</sup> On the one hand, they resort to terrorists or anti-social elements, and on the other hand they face the displeasure of the security forces for publishing reports of issues like human rights violations. It seems that the police officers and army personnel have accepted their path as journalists. Many times the general information is refused to give information citing government secrecy or national security. People believe that human rights are mostly violated by the police. "If journalists expose the incident with appropriate facts, they are harassed only by saying that they are supporters of militant factions."

It is a bitter fact that the press relationship with the police has been tense in all parts of the country. When journalists write about police stagnation, inaction, rape, genocide and poor law and order etc., they start getting caught in the eyes of big police officers. Therefore, the media is unable to play its strong role due to the unsavory attitude of the police. While the main responsibility for the protection of human rights rests with the police, the irony is that incidents of human rights abuses by them are exposed day by day. It remains a matter of concern for the Human Rights Commission and the general workers and media that despite all the efforts, the arbitrariness of the police is not controlled. The highest number of human rights abuses in India are in police custody. Incidents of prisoners in police custody, incidents of sexual harassment of female prisoners and children continue to come to light from time to time. It is also a difficult task to register an FIR in the police stations of most states. The reason for this is that the in-charge of the police station does not want to bring forth the crimes that are coming up in their area. Due to this, tensions between media and police are open. Before the formation of the National Human Rights Commission, information about the pathetic condition of most of the jails was also not available. Even today, there is a lack of communication between the media and the prison system. As a result, incidents of human rights abuses do not come to light.

#### CONCLUSION

The scope of human rights is very wide. If we examine the role of media intensively, then we see many such examples. When in spite of complex circumstances, the media has done its duty well and given its successful commitment in the restoration of human rights. The role of media, its physical size and type of globalization has grown rapidly, but today it cannot be called fair and unbiased and neutral in any way, because media, business and politics have close relationship with each other. The role of media in democracy can only be meaningful if its
