So "Brick House", not only failed to offer wisdom and ideas for the country and the people, but for selfish Xinkouhuzhou, experts completely forget about social responsibility seriously, and even affect social stability. Enhance the credibility of the new think tank as well as to conduct scientific think tank positioned clearly think tanks as research institutions, advisory bodies and service organizations undertaken by national mission and social responsibility, specifically "for whom service"; but also on the think tank experts and strict management, the establishment of strict selection of expert storage quit, words and deeds accountability, monitoring and review of public scrutiny avoidance system, norms "who rely on services"; it is necessary to accurately grasp the direction of think tanks, adhere to the state's major strategic issues as the main direction to the social and public policy issues the research priorities, judged decision to advance the main principle of popular expression in public discourse as the basic paradigm, clarify "what service"; but also to facilitate the effective operation of think tanks, think tanks strengthen collaboration, focusing on broad public participation to build pluralism funding channels to promote the rational evaluation of science, to solve the "how to serve."
